### **Section 3: Required Documents**

1. Tax Clearance Certificate or C2 Details
2. Evidence of Insurance Cover – Public, Product and Employers Liability where applicable
3. Safety Statement
4. Evidence of Product Quality Certification (where applicable)
5. Any other relevant information.

### **Section 4: Terms and Conditions:**

1. I undertake to furnish North Tipperary County Council with a valid Tax Clearance Certificate (“TCC”) or a C2 and Expiry Date. I accept that failure to furnish North Tipperary County Council with a valid TCC/C2 for each year shall result in my removal from the Registered Supplier and Installer List.
2. I understand that in order to remain eligible under the Scheme I am required to be registered on the Register of Suppliers/Installers at all stages during the installation process, including commissioning and the signing off of the Declaration of Works.
3. I declare that I am competent and have the necessary training and experience to enable me to satisfactorily and safely install/commission equipment in the area for which I apply for registration.
4. I undertake to achieve certification at my expense from an accredited training course in respect of each of the technology areas for which I am registered, where applicable. I accept that failure to achieve such certification for all appropriate staff (installers, designers etc) shall result in my removal from the Register of Suppliers/Installers.
5. I accept that installations grant aided under the Scheme and which I commission may, for quality control purposes, be inspected by the Tipperary Energy Agency/North Tipperary County Council or their authorised agents and I will assist, by making myself available and/or disclosing any requested information, and co-operate with any such inspection.
6. I fully consent to the results of such inspections being published by the Tipperary Energy Agency/ North Tipperary County Council or their agents and made available to the public in whatever media the Tipperary Energy Agency or North Tipperary County Council may at its discretion choose.
7. I accept that failure to act on a direction from North Tipperary County Council and/or the Tipperary Energy Agency or their authorised agents, to remedy a deficit identified as a result of an inspection may result in my removal from the Register of Suppliers/Installers
8. I accept that my engaging in fraudulent or inappropriate behaviour in relation to the Scheme will result in my removal from the Register of Suppliers/Installers. I also accept that any failure by me to comply with these Terms and Conditions may result in North Tipperary County Council removing me from the Register.
9. I am aware that North Tipperary County Council may de-register Supplier and Installers where North Tipperary County Council has evidence of repeated failures on the part of Supplier and Installers to deliver quality work or give customer satisfaction. I agree that any dispute between North Tipperary County Council and I in relation to any matter in connection with the Scheme shall in the first instance be discussed between us with a view to finding a resolution. I agree that if the discussion between North Tipperary County Council and I fails, the dispute may be referred by either of the parties to an independent mediator, accredited by the Centre for Effective Dispute Resolution and appointed, in the absence of agreement between the parties, by the Chairman (or his or her deputy) of the Irish Commercial Mediation Association. Any mediation shall take place at a venue chosen by the mediator. The appointed mediator will seek to mediate a resolution of the dispute.

10. I agree that if the dispute between myself and North Tipperary County Council is not resolved in accordance with clause 9, the dispute may then be referred by either party to arbitration under the Arbitration Rules and Procedures of the Chartered Institute of Arbitrators Irish Branch and, in the absence of agreement, either party can apply to the Chartered Institute of Arbitrators Irish Branch to have such an arbitrator appointed.
11. I accept that, in order to be reinstated to the list after deregistration in accordance with these Terms and Conditions, I may be required by North Tipperary County Council to contribute to the costs of any re-inspections arising out of any rework declarations previously issued by North Tipperary County Council or any of its agents or contractors. Furthermore I accept that I may be required by North Tipperary County Council to contribute to the cost of a number of inspections carried out on my installations after re-registration.
12. I agree at my expense to attend targeted workshops when requested by North Tipperary County Council and/or the Tipperary Energy Agency.
13. I undertake that the services provided by me pursuant to the Scheme will be carried out in accordance with recognised and accepted practices, acceptable industry standards and any applicable equipment installation guidelines and any relevant national and European laws and guidelines.
14. I accept that the Terms and Conditions for registration on the Registered Supplier and Installer List may be updated from time to time on the SERVE website and these updated Terms and Conditions shall apply to me with immediate effect.
